

The MOSFETs in this device are sensitive to electrostatic discharge. When handling this device, the worktables, operators, soldering irons and other objects should be protected against anti-static discharge.

Note: The channel-to-ambient thermal resistance, R_{th(ch-a)}, and the drain power dissipation, P_D, vary according to the board material, board area, board thickness and pad area. When using this device, be sure to take heat dissipation fully into account.






Fig. 6.3.1 Switching Time Test Circuit






Fig. 8.1 I_D - V_{DS}




Fig. 8.3 R_{DS(ON)} - V_{GS}




Fig. 8.5 R_{DS(ON)} - T_a




Fig. 8.2 I_D - V_{GS}




Fig. 8.4 R_{DS(ON)} - I_D







Fig. 8.6 V_{th} - T_a




Fig. 8.11 rth - tw




Fig. 8.8 C - V_{DS}




Fig. 8.10 t - I_D





Fig. 8.12 Safe Operating Area




