Subject : NT-MIL Flexible, Rugged Modified Elastomer Tubing Specified to AS23053/1

Description of Change : Our current M23053/1 deliveries are affected by a vendor forced change to one of the resins used in the raw material. We have tested and confirmed that the new compound meets internal testing requirements and are submitting testing to NAVAIR for qualification approval. There has not been an escape of this material.

Currently, we cannot ship under M23053/1 NT-MIL tubing under standard part numbers before we have the DoD qualification and release on the reformulated compound. We believe this could be a 6-month timeline, but that will depend on the DoD.

Reason for Change: Part status change.Additional Reason for Change If the M23053/1 QPL is required, we either need a waiver for the use of non-qualified compound/tubing from the MRB authority for the DoD program the product is being used on; or there is a DD-1694 authority from the US DoD program.

We can supply and ship the commercial equivalent (attached), which is the same product as MIL but released to TE internal qualification reference RW3030 for NT-MIL. The commercial parts are under a different part number and part description, but are made on the same machines and to the same parameters as the formerly qualified QPL material (so no change to form, fit, or function).
