1. Purpose



2. Overview


The design of the central fixed contact will be updated to align with the KSC standard, reducing the risk of intermittent lack of the electrical contact.

An anti-particle design will be implemented to create a circular electrical contact, ensuring reliable connectivity even in cases of contamination on the contact surface. This design features multiple electrical contact points, as opposed to a single flat surface, significantly decreasing the likelihood of electrical contact failure.
