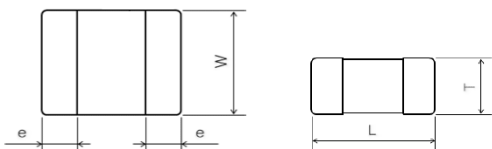

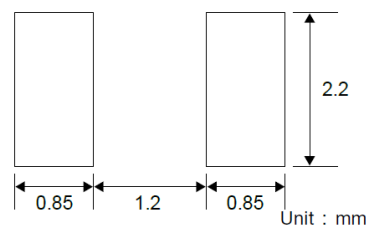

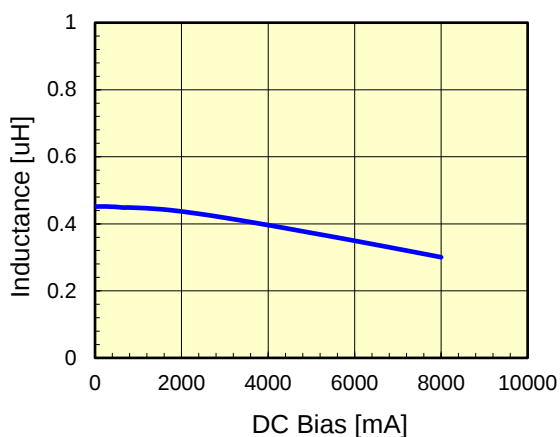

Wire Wound Inductor

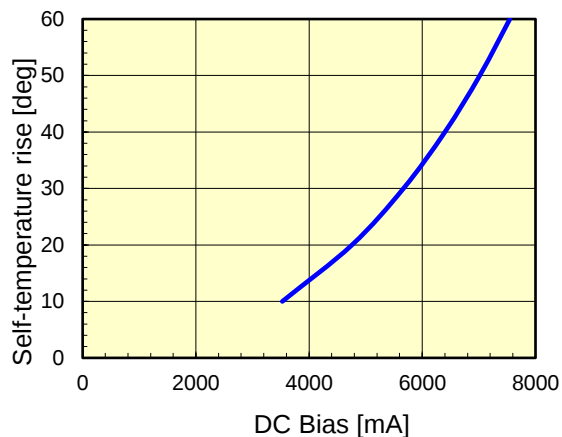

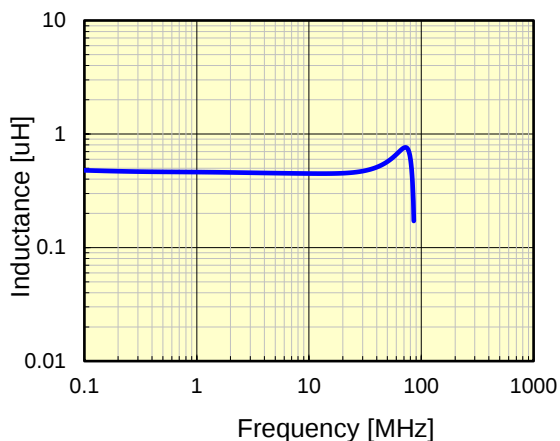
DC Bias vs Inductance
