

Operating Current Derating

For continuous operation, it is recommended that shunts are not operated at more than two thirds (2/3) the rated current under normal conditions per IEEE standards for DC instrument shunts. At ambient temperatures above 40 $^{\circ}$ C, the current must be further derated to prevent damage.
