3. HAZARDS IDENTIFICATION

4. FIRST AID MEASURES

Eyes : Rinse immediately with plenty of water, holding the eyelids open and seek medical advice if effects persist.

6. ACCIDENTAL RELEASE MEASURES

Hose away with plenty of water diluting to at least 5% w/v (50 g/litre) unless this would contaminate a water course or vegetation, in which case either collect, dilute as earlier and pour down wastewater drain (foul sewer) or absorb onto dry sand or similar material and dispose of safely as commercial waste.

7. HANDLING & STORAGE

Avoid contact with eyes. Rinse and dry hands after use, for prolonged contact protection of the hands may be necessary. Do not mix with any other chemicals other than as advised by your JohnsonDiversey representative.

Store upright in original closed containers in a cool place.
