
This device has been designed for applications requiring narrow brightness and color selection.

It consists of a lead frame which is embedded in a white thermoplast. The reflector inside this package is filled up with clear epoxy.

In a similar manner for colors where wavelength groups are measured and binned, single wavelength groups will be shipped on any one reel.






Figure 1. Forward Current vs. Ambient Temperature




Figure 2. Forward Current vs. Pulse Length




Figure 3. Rel. Luminous Intensity vs. Angular Displacement




Figure 4. Relative Intensity vs. Wavelength




Figure 5. Forward Current vs. Forward Voltage




Figure 6. Relative Luminous Intensity vs. Forward Current






Figure 7. Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle






Figure 8. Rel. Luminous Intensity vs. Ambient Temperature





METHOD OF TAPING/POLARITY AND TAPE AND REEL

SMD LED (VLM.3 - SERIES)

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO) 564) for automatic component insertion. The blister tape is a plastic strip with impressed component cavities, covered by a top tape.




Figure 9. Tape dimensions in mm for PLCC-2 $\,$

REEL PACKAGE DIMENSION IN MM FOR SMD LEDS, TAPE OPTION GS08 (= 1500 PCS.)




Figure 10. Reel dimensions - GS08

REEL PACKAGE DIMENSION IN MM FOR SMD LEDS, TAPE OPTION GS18 (= 8000 PCS.) PREFERED




Figure 11. Reel dimensions - GS18

IR Reflow Soldering Profile for lead free soldering Preconditioning acc. to JEDEC Level 2a




Figure 12. Vishay Leadfree Reflow Soldering Profile (acc. to J-STD-020C)





Figure 13. Double wave soldering of opto devices (all packages)



DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminium bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:


- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

After more than 672 hours under these conditions moisture content will be too high for reflow soldering. In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 hours at 40 °C + 5 °C/ - 0 °C and < 5 % RH (dry air/ nitrogen) or

96 hours at 60 $^{\circ}$ C + 5 $^{\circ}$ C and < 5 $^{\circ}$ RH for all device containers or

24 hours at 100 °C + 5 °C not suitable for reel or tubes. An EIA JEDEC Standard JESD22-A112 Level 2a label is included on all dry bags.

ESD PRECAUTION

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the Antistatic Shielding Bag. Electro-Static Sensitive Devices warning labels are on the packaging.
