To ensure the operating mode of the product, the ambient temperature at processing (when the part will be mounted on the cable) has to be in the range of 15 to 25 °C.Before mounting, the part should be stored for one hour in this condition. Direct mechanical impact to the product and the forcible closing of this shall be prevented as the ferrite material of the ferrite body or the plastic housing could flake or in the worst case it could break.

- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
