## EVO-STIK ADHESIVE CLEANER (191) A SOLVENT BASED CLEANER

Evo-Stik Adhesive Cleaner (191) is a mixture of solvents for cleaning Evo-Stik adhesive from equipment, preparing substrates etc. Before using this product refer to the relevant Health & Safety Data Sheet.

- Toluene free

### Uses

- Cleaning substrates prior to bonding, in particular rubber, metals and many other impervious surfaces.
- To clean adhesive from equipment.
- To remove small dried deposits of contact adhesives from surfaces.
- Diluting Evo-Stik 528 Contact Adhesive and Evo-Stik Impact Adhesive for priming very porous substrates.

### Directions for use

#### IMPORTANT

Before using Evo-Stik Adhesive Cleaner (191) refer to the relevant Health & Safety Data Sheet. Available at [www.bostik.co.uk](http://www.bostik.co.uk) named as the code above.

#### Preparation

1. Open any windows and doors to ensure good ventilation. Push down and unscrew to remove cap. Ensure container is properly sealed after use.

#### Application

1. Wearing gloves, use cloths made into pads and moisten them with the cleaner. Use the pad to vigorously rub the surface.
2. In the case of rubbers, particularly black rubbers, some of the black may appear on the cloth; this is normal.
3. Always repeat the process with another clean pad moistened with cleaner.
4. Leave cloths outside until fully dry before disposal.

#### Cleaning adhesive from equipment

5. The use of a number of washings with small quantities of cleaner is far more efficient than a single large washing.

#### Removal of dried adhesive

6. Always try to minimise the amount of cleaner used.

7. Therefore attempt to remove the bulk of the material to be cleaned by mechanical means as this will drastically reduce the amount of cleaner required.

N.B. This cleaner is not designed to remove old deposits of adhesive from ceilings, walls and floors. The cleaner cannot stay in contact with the adhesive long enough to soften the deposits before the solvent runs away or evaporates.

### **Priming very porous substrates**

1. Only prepare enough for immediate use.
2. Dilute Evo-Stik 528, Evo-Stik 613 or Evo-Stik Impact Adhesive with an, approximately, equal volume of Evo-Stik Adhesive in a clean container.
3. Always add cleaner to adhesive, slowly, with gentle stirring.
4. Stir well.

### **Precautions in Use**

Work in a very well ventilated area and avoid breathing the vapours. Ensure that any source or potential source of ignition is removed/isolated. Always test the effects of the cleaner on an unseen or test area to determine its suitability; it may damage some sensitive surfaces. Always try to use the minimum amount of cleaner/solvent. Wear gloves and safety glasses.
