Surface Preparation

- 1. Make sure that the surfaces to be bonded are clean, dry and free from dust, dirt and grease.
- 2. Protect nearby polished, cellulose or any other sensitive surfaces as the adhesive may spoil the finish.

Application

- To bond non-absorbent surfaces such as metal or glass apply a thin film of adhesive to both surfaces. Allow 5 to 10 minutes drying time and then, having correctly positioned the surfaces, press them together firmly.
- If one or both surfaces are absorbent apply a generous film of adhesive to one surface only and immediately join the two surfaces together under pressure. Using this technique initial bond strengths may be a little lower.

Cleaning

- Remove surplus adhesive by the use of nail polish remover or acetone.
- Dry adhesive is not easy to remove, particularly from sensitive surfaces that the solvent in the adhesive may already have damaged. It is advisable to work carefully on protected surfaces to reduce the problem.

Precautions in Use

Bostik All Purpose Clear Adhesive will not bond Polythene (polyethylene), polypropylene or Teflon.

Bostik All Purpose Clear Adhesive unsuitable for use on Polystyrene, Cellulose paint, Rayon and acetate fabrics. This is because the solvent in the adhesive will damage the materials.

Bostik All Purpose Clear Adhesive is unsuitable for repairing pottery handles or other items that may contain hot liquids.
