

# BP1730 Lithium-Ion Battery Pack Safety Information

# Safe Storage

- Do not remove a battery pack from its original packaging until required for use.
- Keep the battery pack out of the reach of children and animals.

### **∧** Marning

To prevent possible electrical shock, fire, or personal injury:

- Read all safety information before you use the Product.
- Use the Product only as specified, or the protection supplied by the Product can be compromised.
- Carefully read all instructions.
- Charge the battery only when installed in the Fluke 1730 Energy Logger.
- Do not use the Product around explosive gas, vapor, or in damp or wet environments.
- Examine the case before you use the Product. Look for cracks or missing plastic. Carefully look at the insulation around the terminals.
- Batteries contain hazardous chemicals that can cause burns or explode. If exposure to chemicals occurs, clean with water and get medical aid.
- Remove the batteries if the Product is not used for an extended period of time, or if stored in temperatures above 50 °C. If the batteries are not removed, battery leakage can damage the Product.
- · Do not short the battery terminals together.
- Do not disassemble or crush battery cells and battery packs.
- Do not put battery cells and battery packs near heat or fire. Do not put in sunlight.
- Do not continuously charge battery packs when not in use.
- Do not expose battery pack to mechanical shock.
- Do not open the battery pack. There are no user serviceable parts inside.
- Refer to the Product manual for proper instructions on charging the battery pack.
- Do not transport damaged batteries by air.

# Safe Disposal

- A failed battery pack shall be properly disposed of in accordance with local regulations.
- Dispose of properly: do not dispose of the battery as unsorted municipal waste. Go to Fluke's website for recycling information.
- Dispose in discharged condition and cover the battery terminals with isolation tape.
