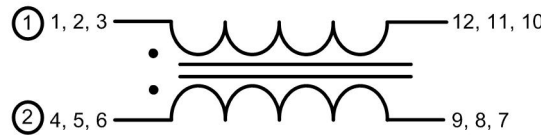

C Schematic:



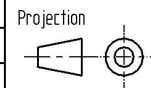

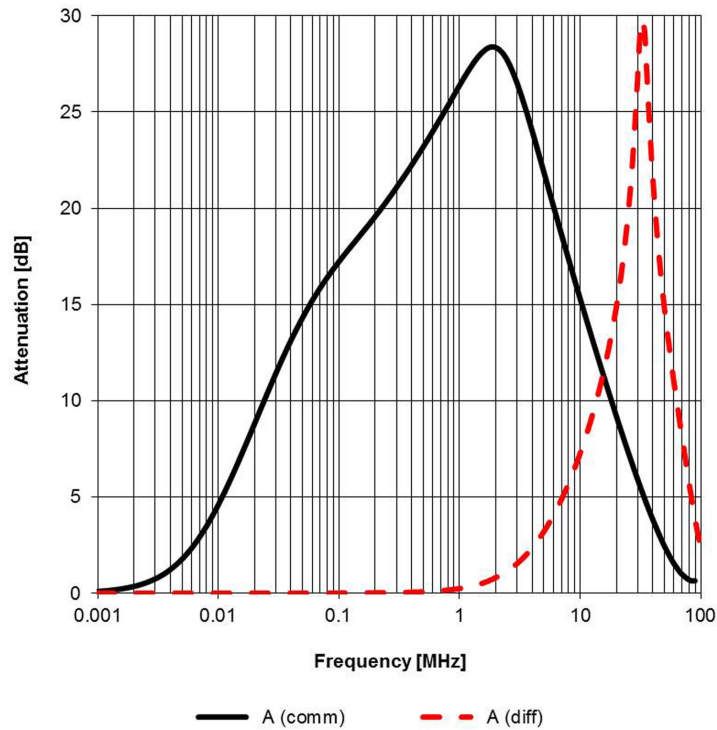
