#### PREPARATION

- 1. The surfaces must be clean, dry and free from any dust or loose material.
- 2. For best results, surfaces and surroundings should be pleasantly warm.

#### APPLICATION

- 3. Apply Bostik Tape Discs by peeling from the clear liner and positioning into place.
- 4. Remaining sheets can be stored in the wallet pack for later use.

## CLEANING

5. Bostik Tape Discs can be carefully peeled from a hard surface.

# **PRECAUTIONS IN USE**

Bostik Tape Discs are unsuitable for use on very absorbent, damp, dusty, delicate or newly decorated surfaces. If in doubt carry out a small test, first. Place precisely onto gift wrap as removal will usually result in the paper tearing.
