



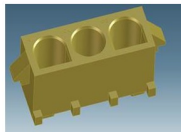

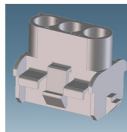

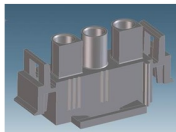
MLX products produced in Molex Bangalore Plant, India (8203)

Overview

- To better serve our customers and leverage Molex India manufacturing capacity, in October, 2017, Molex India will begin shipping a number of MLX® parts from Molex Gandhinagar, Gujarat plant. Over the course of the following 12 months, Molex will be completing additional tooling as well as executing transfers of certain tooling used to produce MLX® parts. These transfers include finished goods and components that are being made in Bangalore plant. During this period MLX® connectors may be shipped to customers from the current Molex manufacturing location of Bangalore or the new Molex location of Gandhinagar, India. Molex will manage the transfer schedule appropriately to ensure quality expectations are met while maintaining ongoing deliveries. The transfers are expected to be completed by 30th September, 2017. The Molex facility in Gandhinagar is an established ISO/TS 16949 plant and is already the home of many Automotive connectors. This transfer will allow Molex to continue our tradition of excellent quality and improve our overall capacity. Packaging will clearly denote where finished goods were manufactured.
