Shake the can and spray directly and liberally onto affected area. Allow time to penetrate (two minutes to 1 hour depending on type of stain) then wipe away graffiti and rinse area with water. For stubborn stains, dry area and repeat process.

- Do not apply when ambient surface temperature is below 5°C
