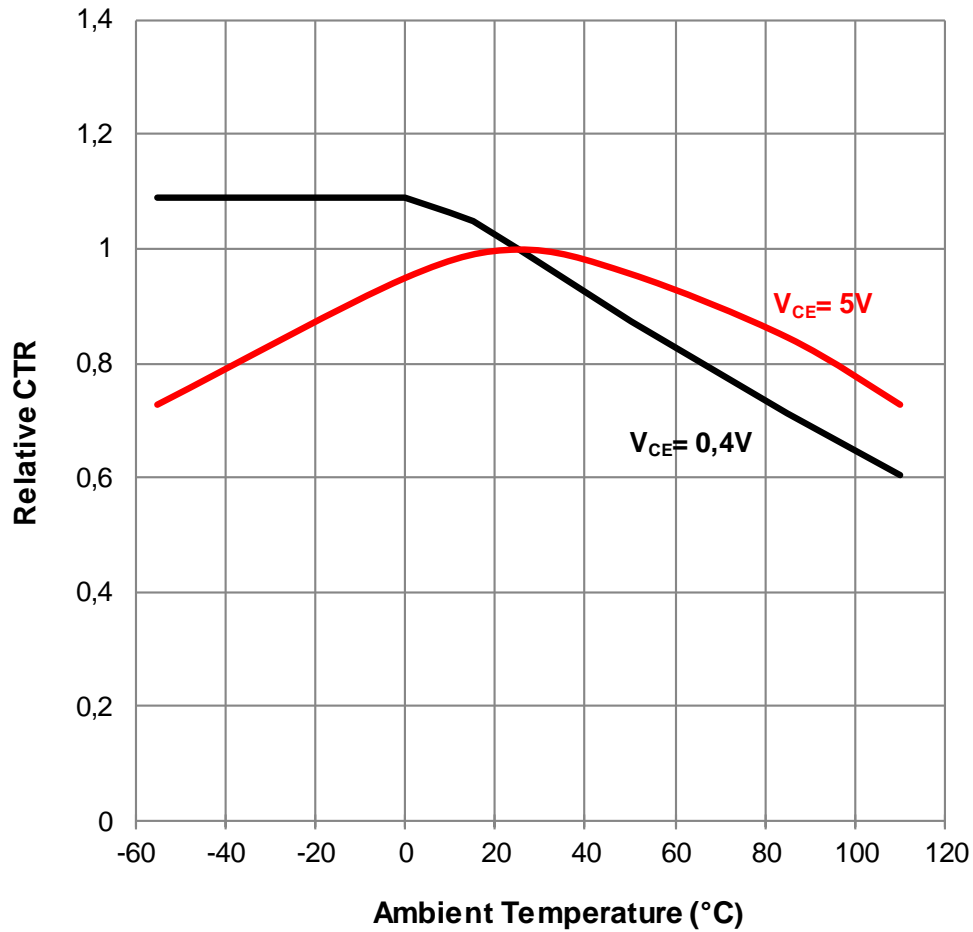
Collector Dark Current vs. Ambient Temperature:

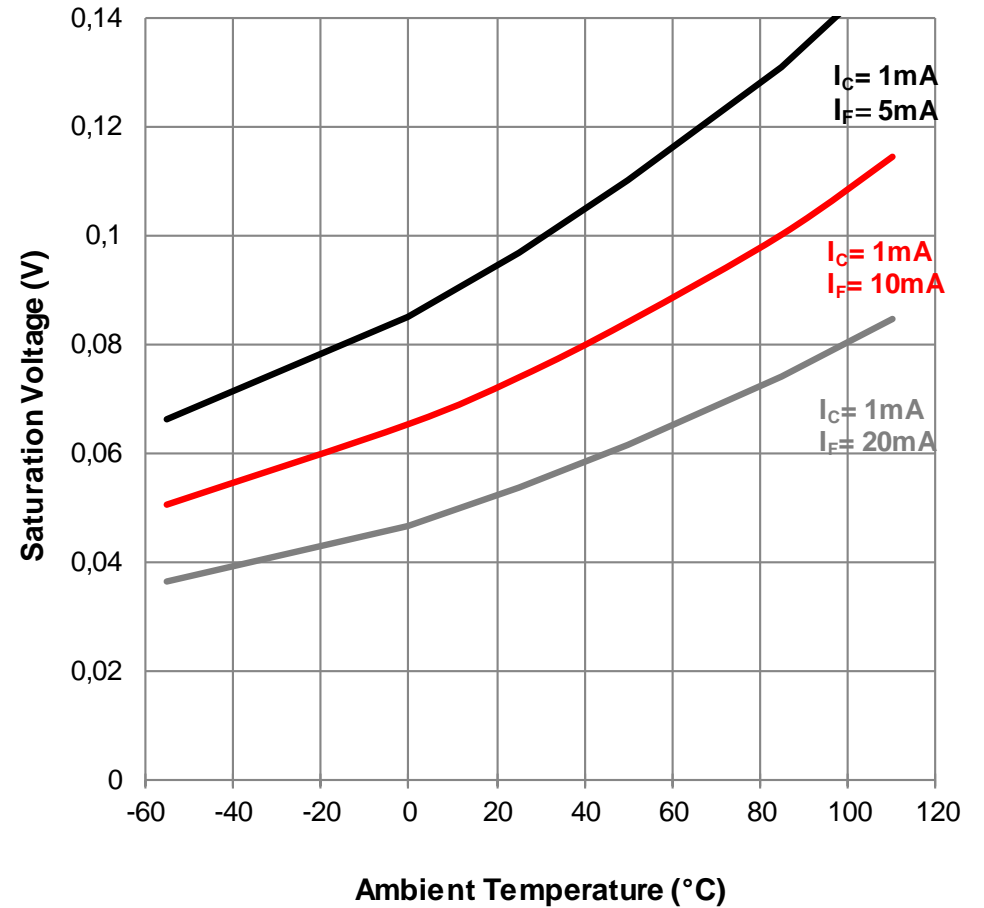

Relative CTR vs. Ambient Temperature:



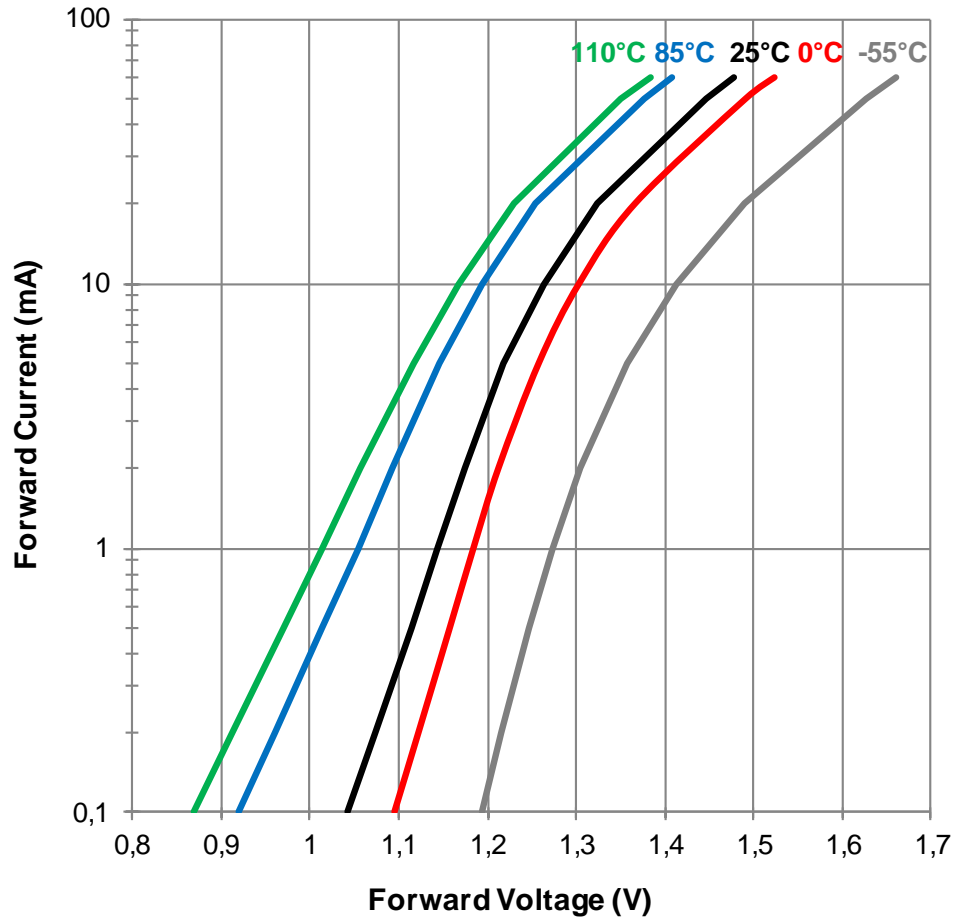

Collector-Emitter Saturation Voltage vs. Ambient Temperature:

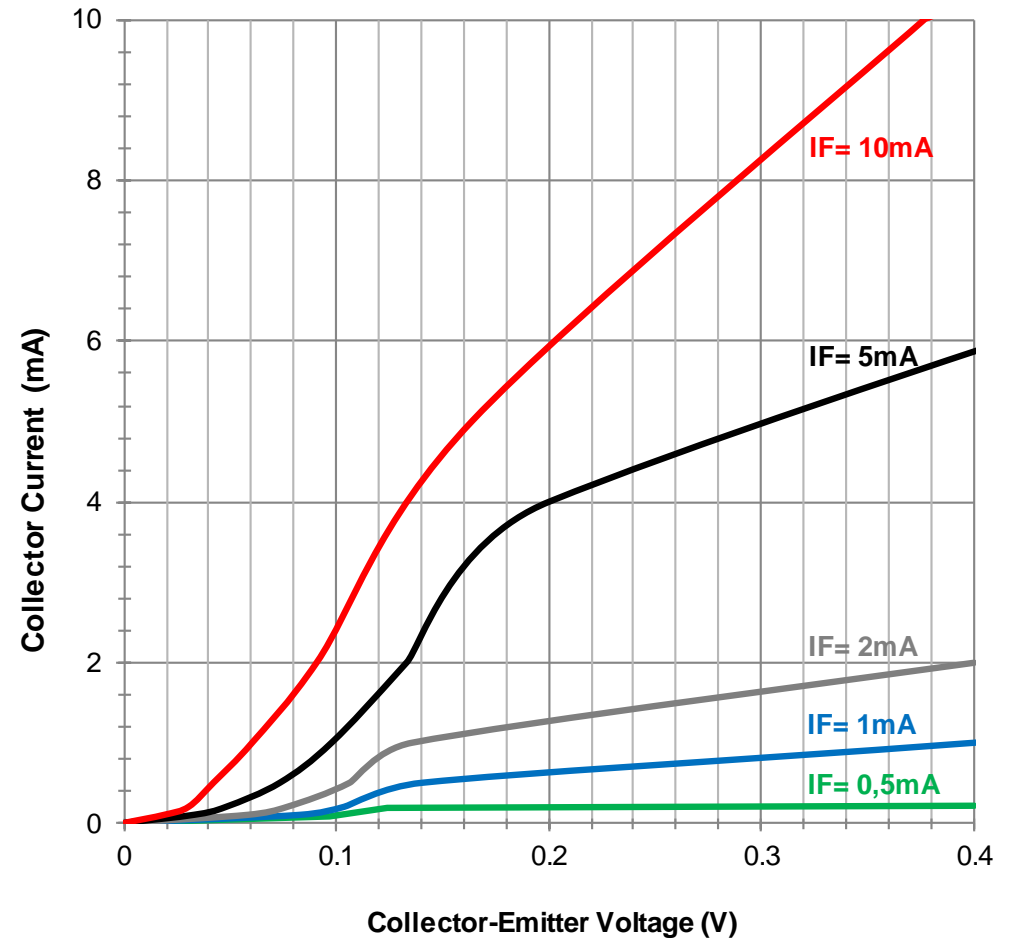

Forward Current vs. Forward Voltage:



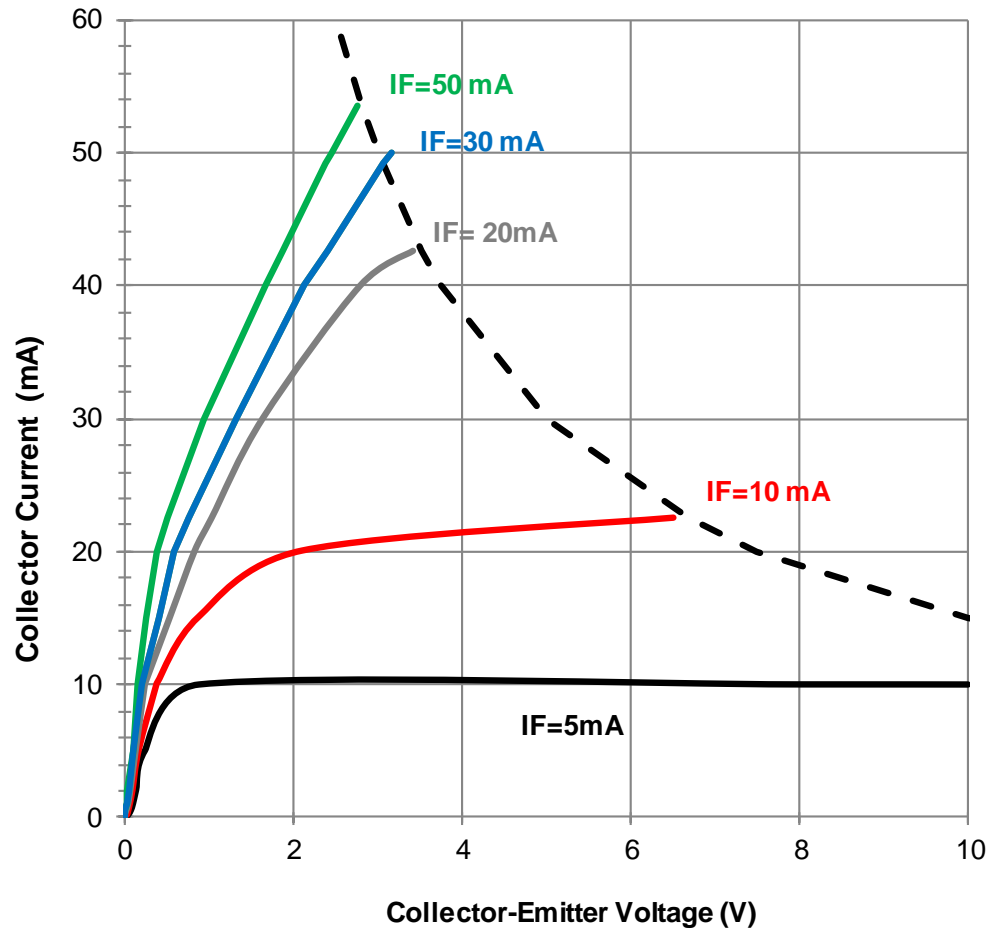
Collector Current vs. Collector-Emitter Voltage:

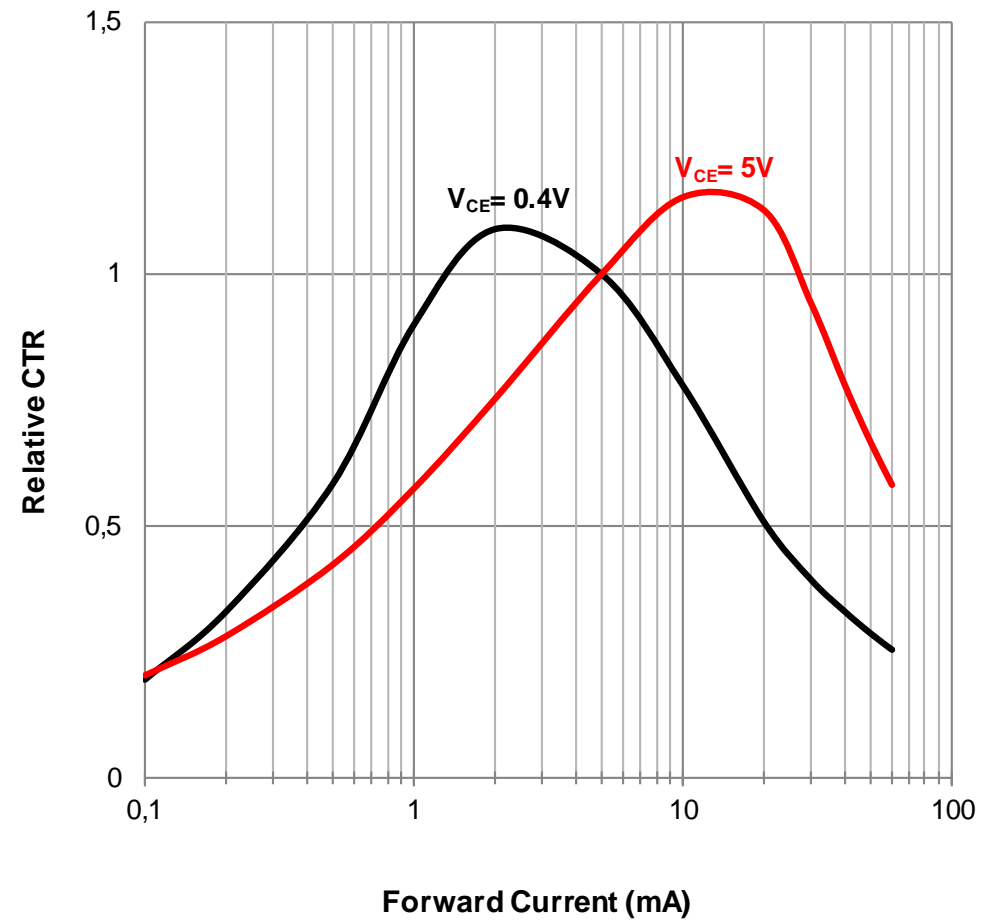

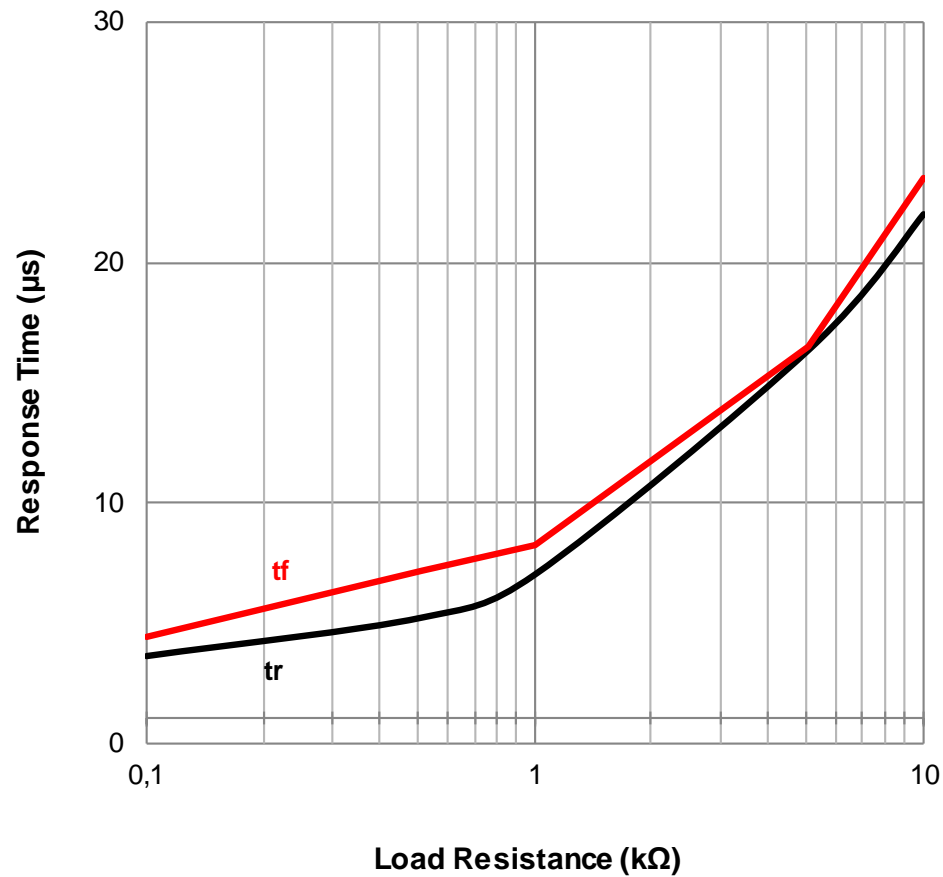
Relative CTR vs. Forward Current:

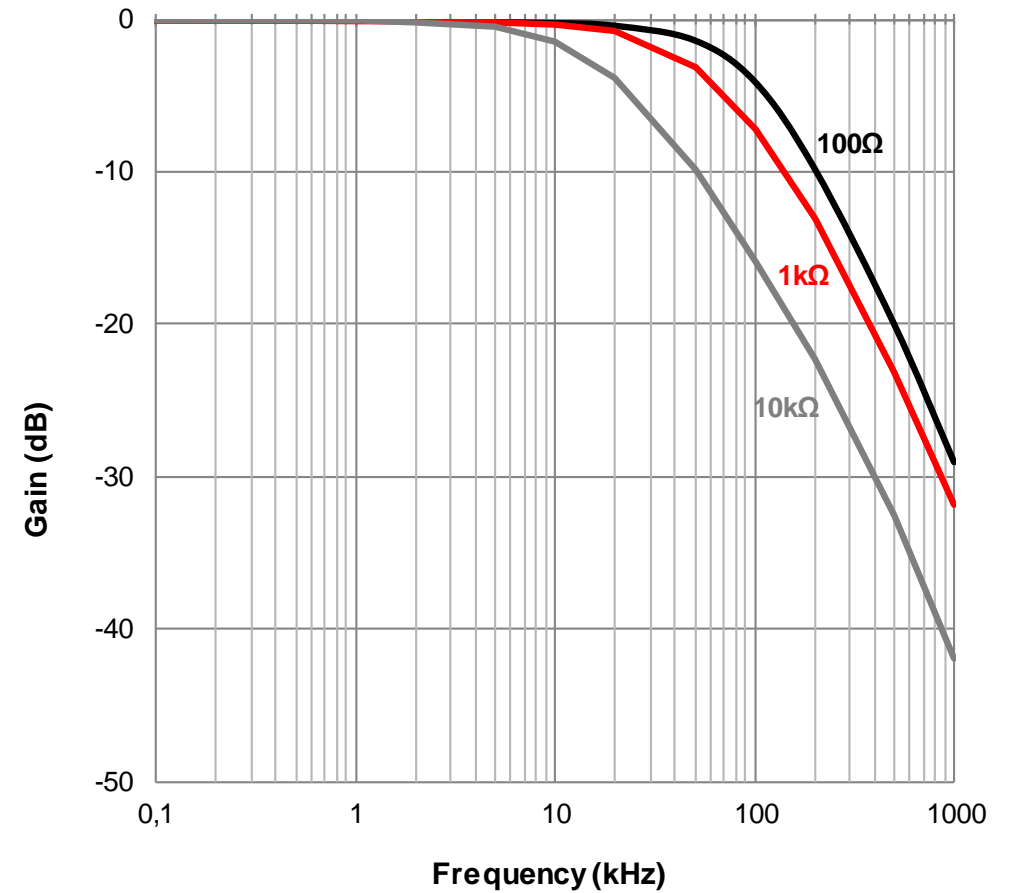

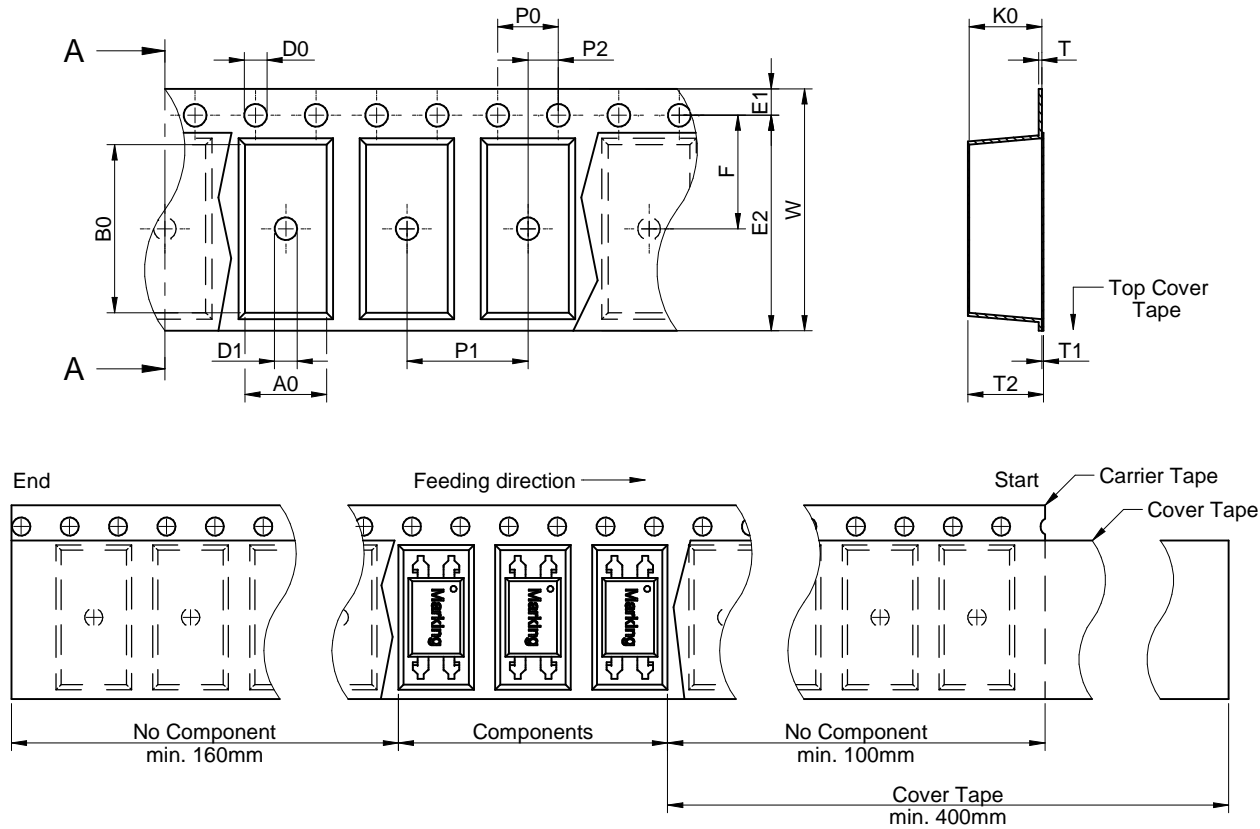
Frequency Response:

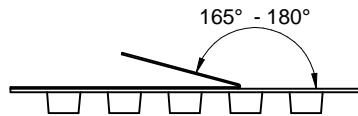

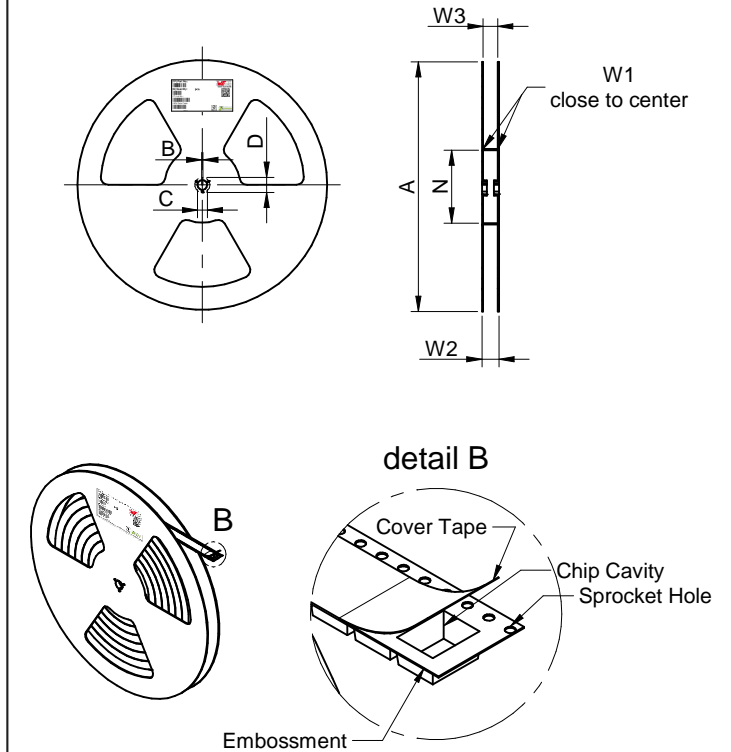

Soldering:




