In order to ensure component availability, there will be a second source of housing implemented in addition to the existing machined aluminium housing. The new components will be produced using die cast plus machining processes. There will be an added groove on the outer surface of the existing machined type T2 housing in order to differentiate between these two resolver housing sources in case of dual use.
