### Total Power Dissipation vs. Ambient Temperature:

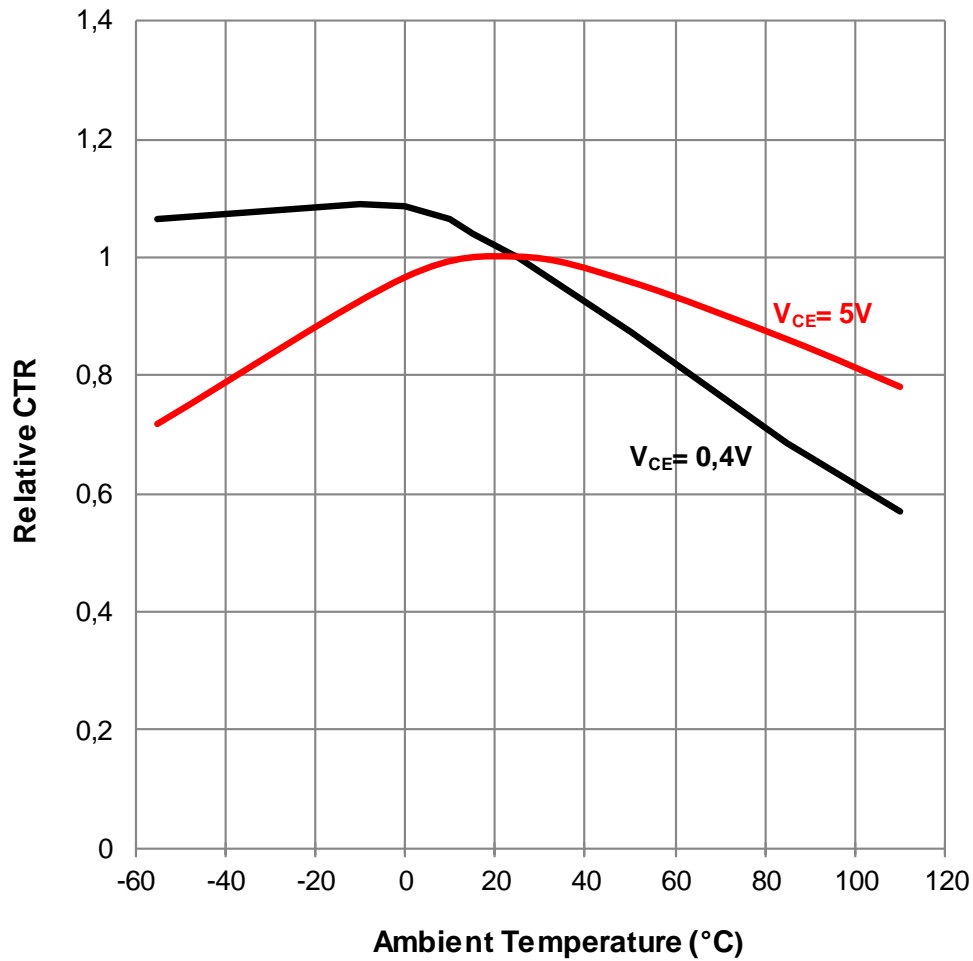


### Collector Dark Current vs. Ambient Temperature:



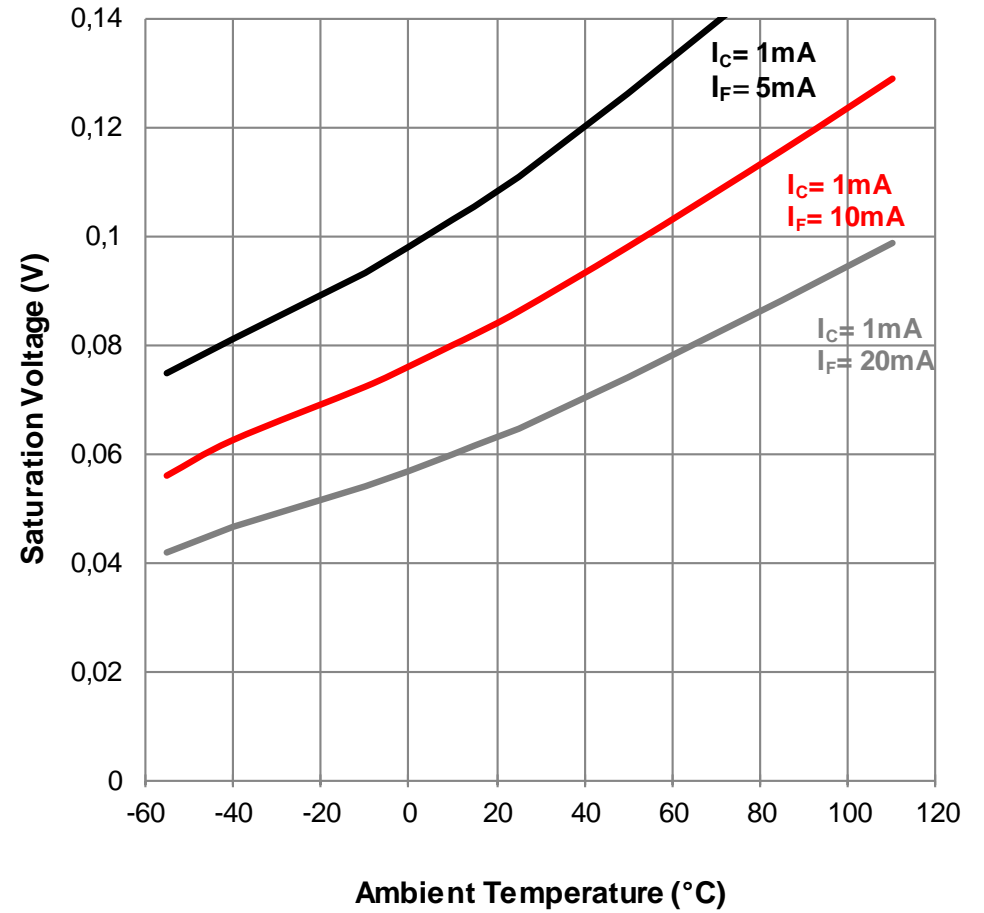

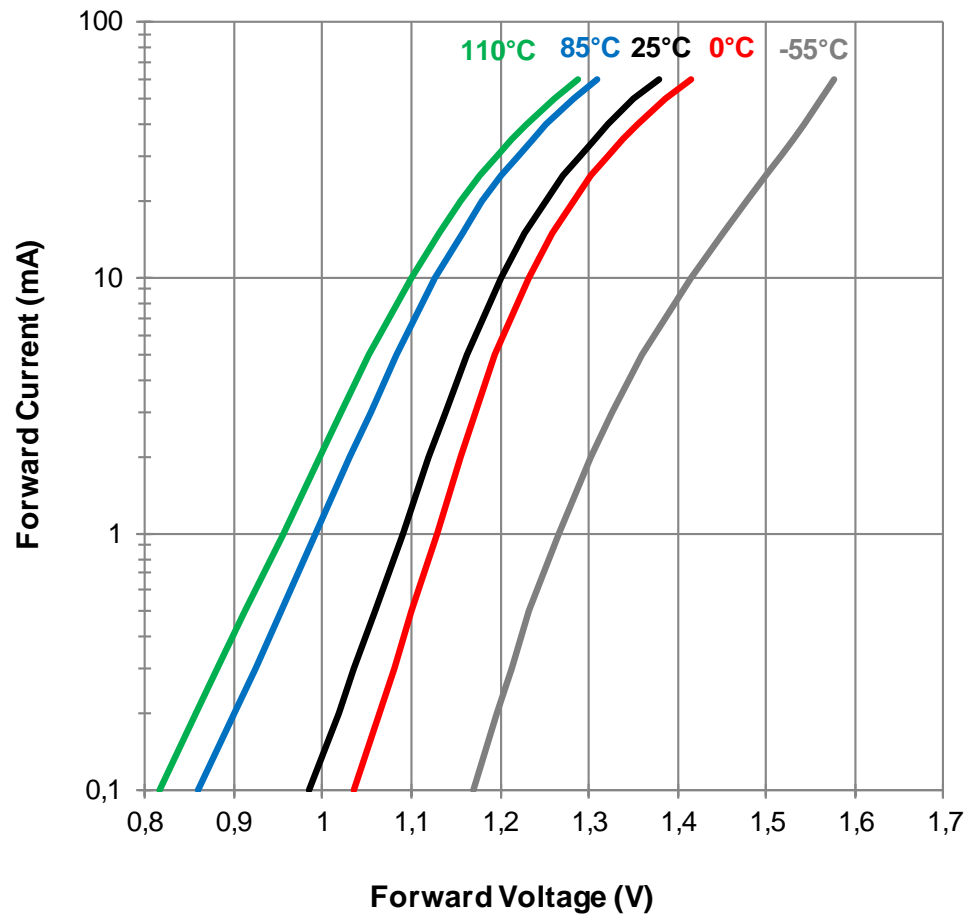
### Collector-Emitter Saturation Voltage vs. Ambient Temperature:



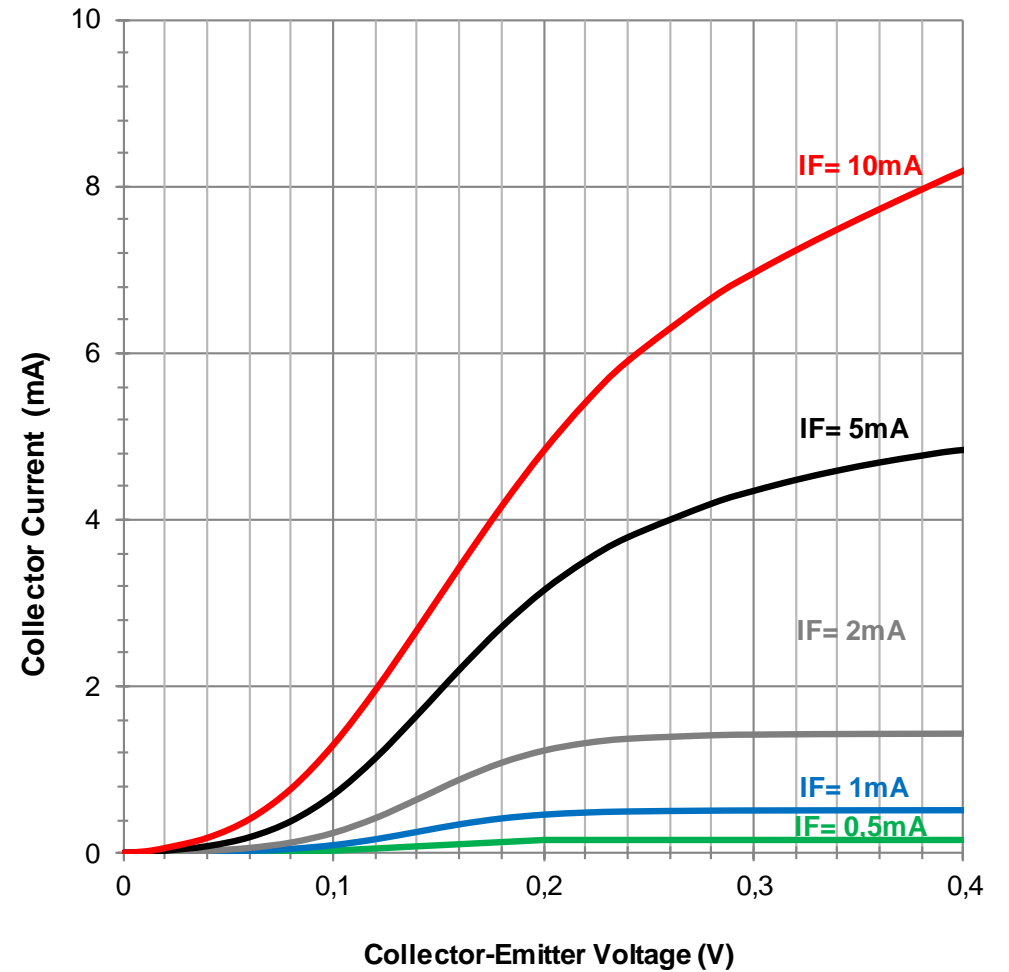

### Collector Current vs. Collector-Emitter Voltage:

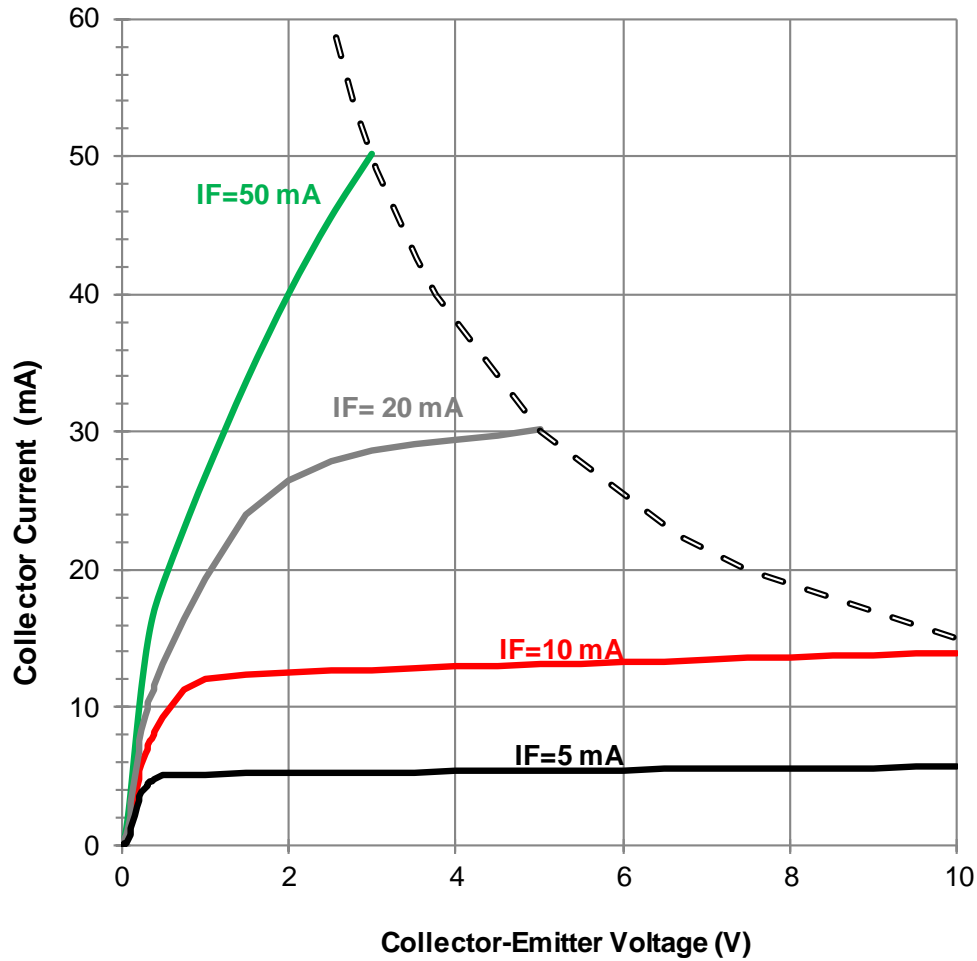

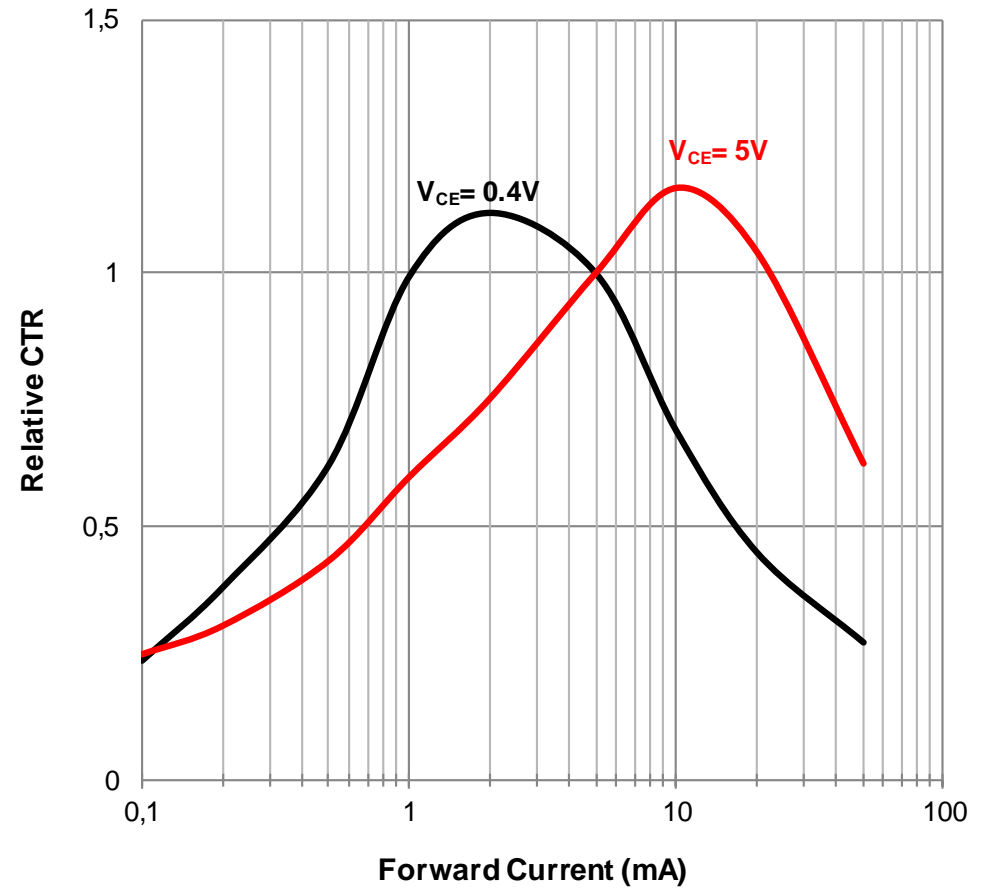

### Relative CTR vs. Forward Current:



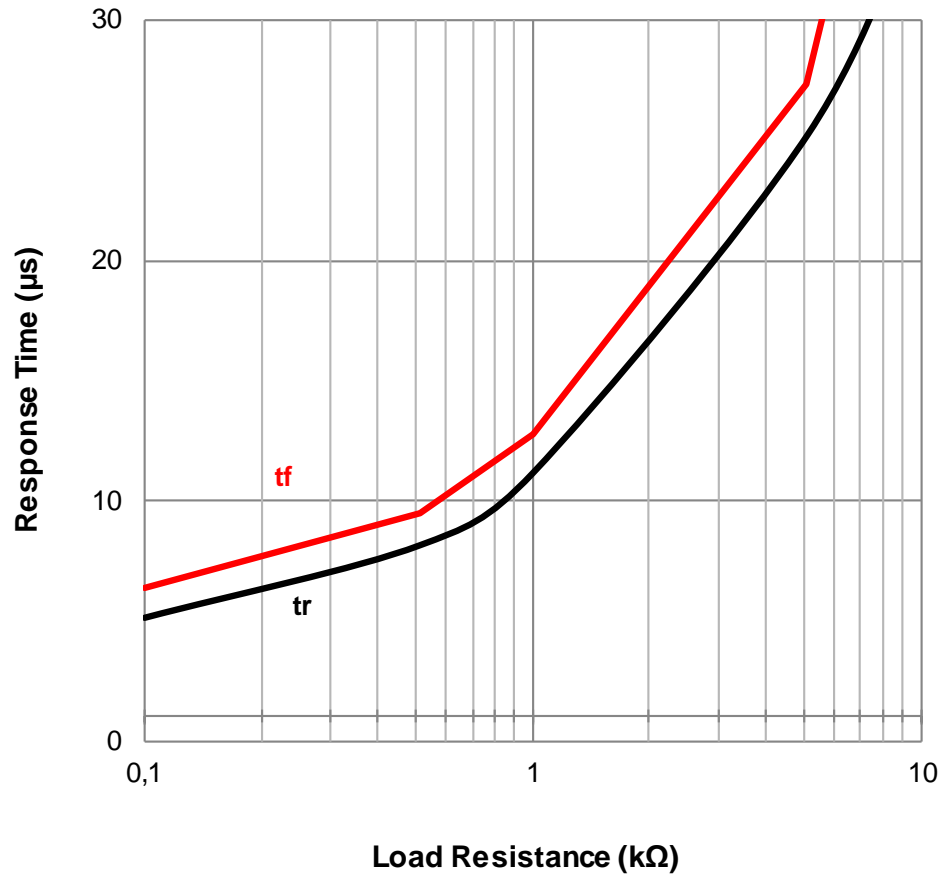

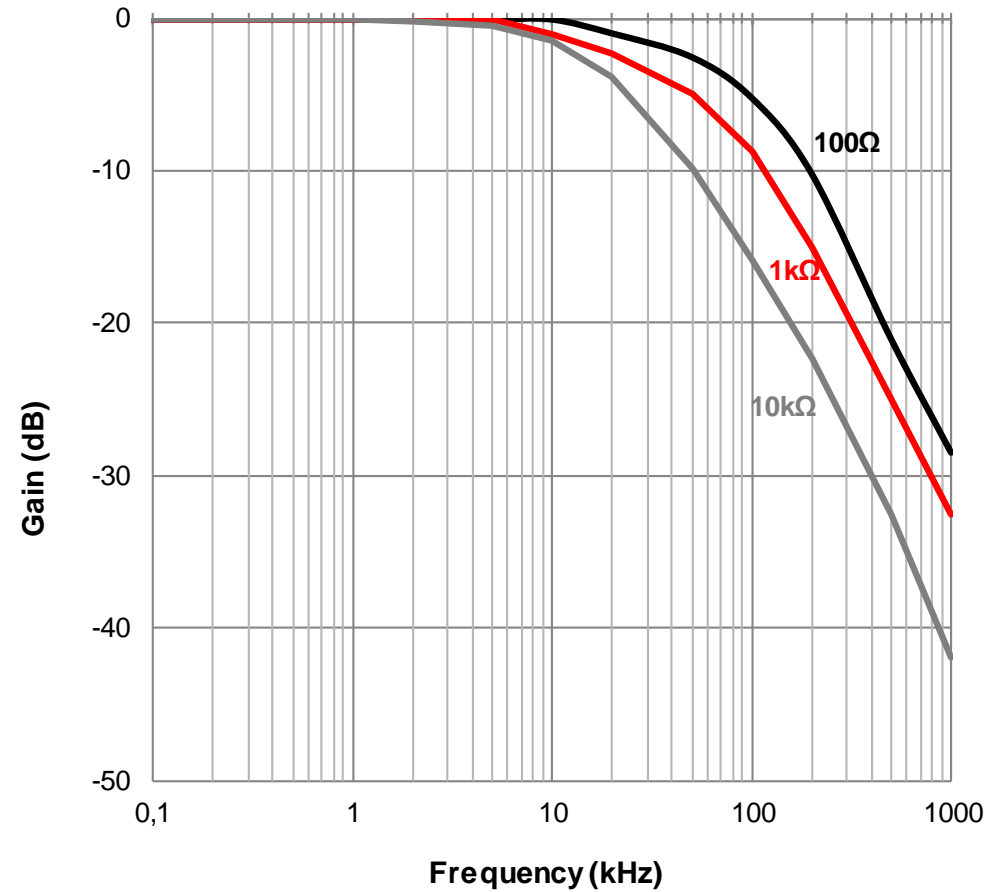

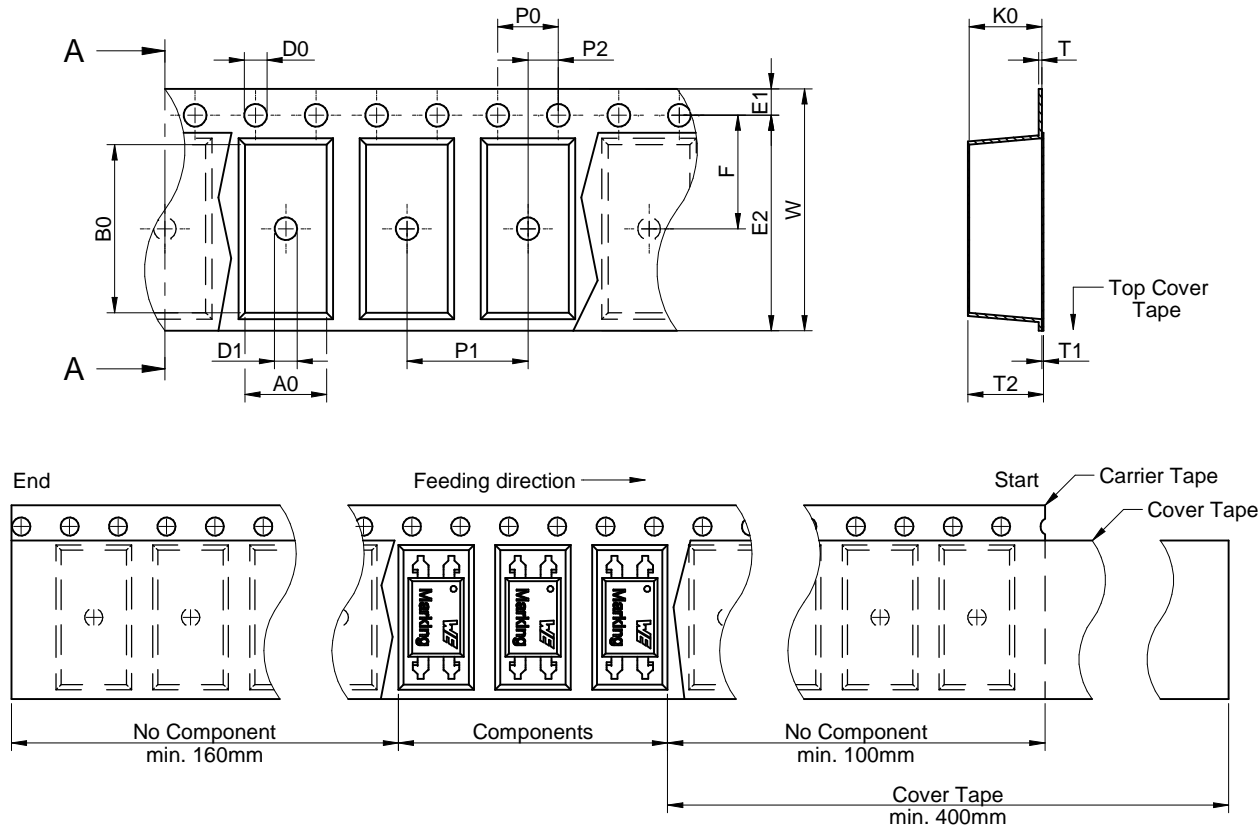
### Gain vs. Frequency:

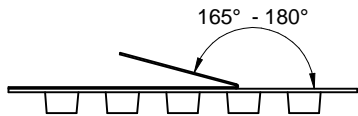

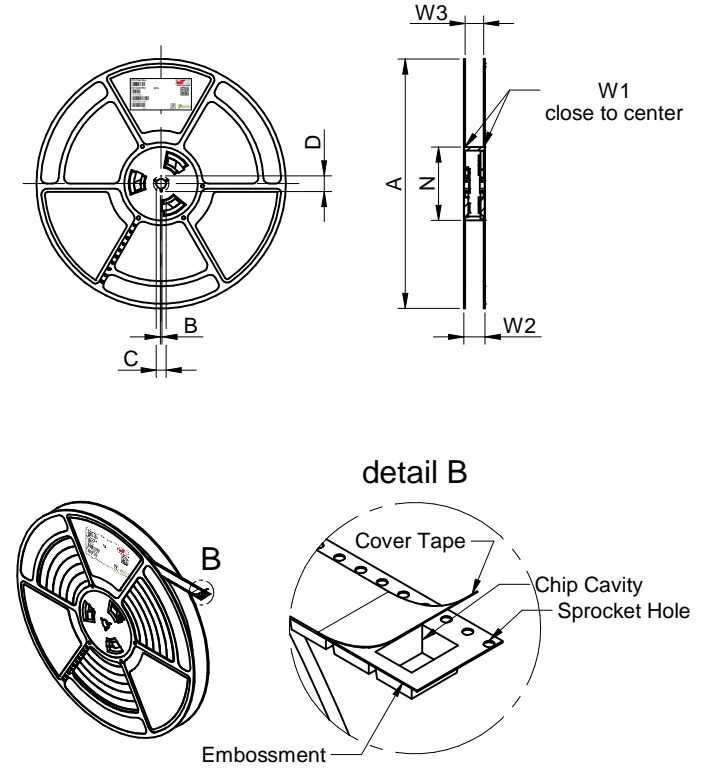

#### Soldering:




