#### SECTION 4: First aid measures

# 4.1. Description of first aid measures

**General information** Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

**Inhalation** Remove affected person from source of contamination. Move affected person to fresh air and

keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on

their side in the recovery position and ensure breathing can take place.

#### 5.3. Advice for firefighters

Protective actions during firefighting

Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. ## 7.1. Precautions for safe handling

#### Usage precautions

# Appropriate engineering controls

Provide adequate ventilation.
