Description and Purpose:

This notification is a follow-up to Product Discontinuance Notice PD23383ZA issued on products sourced from our fab in Belgium. Due to market conditions exceeding previous performance and forecast, it has become necessary to tighten our understanding of our customer lifetime needs and request that you pursue order placement for all affected products by April 15, 2021. This acceleration is to insure that we have ample time to agree on and build requested volumes.
