From time-to-time we find it necessary to change, modify, replace, or obsolete our older product offerings. These changes are usually the result of

- a)).. Advancements in Technology that offer improvements in performance or manufacturability.
- b)).. Unavailability of component parts, generally of an earlier technology or an older design.
- c)).. Changes in Legislation that require product families to be upgraded to meet such requirements.

As you maybe aware recent EU legislation for CE marking for the Low Voltage Directive (LVD) has obsoleted EN60950 compliant products since 20/12/2020, in favour of new EN62368 requirements for CE marking. Artesyn have reviewed the listed Product Series below, which cannot comply to EN62368 requirements without significant redesign. Therefore existing CE mark & associated EN Licence marks must be removed & Artesyn are no longer authorised to ship such direct to EU legislation countries.

Please note that such non-Compliant EU Product Series remain active for shipment outside the EU (eg USA / Asia etc) until further notice. A Full listing of End of Life products & further information is available in the My Power portal of our Website.

We sincerely appreciate your business and will make every effort to work with you during your transition to the new power supplies. In some cases of obsolescence, a new advanced model has been introduced to replace the existing power supplies. We recommended a suitable nearest replacement for your convenience on most of the end-of-life models.
