- The increasing global demand has caused a global shortage of various metal. This extraordinary situation, in conjunction with an already constrained market, has caused immediate and severe disruption in the industry.
- Due to these supply constraints, Molex identified an internal shortage of metal supply which would create a challenge to fulfill all orders. Therefore, we identified an alternative sourcing for the product families listed above. After applying of this change, Molex products listed above will be manufactured by one of them - the current supplier's material or the alternative supplier's one by the metal material supply situation.

## After Change

- The alternative suppliers operate under ISO9001 certified QMS.
- Molex material scientists conducted comprehensive equivalency analysis comparing properties of metals between the original supplier and alternative supplier. This is being followed by Molex internal qualification testing which shall ensure that finished products meet relevant product specifications before delivery.
- There is no expected change regarding form, fit or function.
- Identification:  
For the first 6 months of the production start by the alternative material, we will add "M" at the end of Traceability number of the label to identify products made from alternative materials.
- We apologize for the inconvenience, but in view of the urgency of this matter, if there is no particular reply to the change notified by this PCN, it will be considered that the change have been approved and will be implemented with the above Planned implementation Date.
