PREPARATION

1. Ensure the surfaces to which the adhesives is to be applied, are clean and dry.

APPLICATION

2. Remove the cap and turn the tube base clockwise to extends the glue stick.
3. Apply the glue stick with even strokes.
4. Press the surface to be glued together immediately
5. Wind the glue stick back down from the tube by turning the base anti-clockwise.
6. Replace the cap after use

CLEANING

7. Excess adhesive maybe removed with damp cloth.
8. Adhesive on clothing may be washed out of clothing before the adhesive sets

PRECAUTIONS IN USE

Not suitable for damp, delicate, absorbent and newly decorated surfaces. If in doubt, test small area, first. The adhesives gets stronger with time, so take care when removing..
