### **Description of Changes**

Dear valued customer, we want to inform you about the extending to the current Intercontec production line at TE Niederwinkling /Germany by adding new equipment and increase capacities in TE plant in Bydgoszcz /Poland - Tyco Electronics Polska Sp. z o.o., Unii Lubelskiej 4, 85-059 Bydgoszcz. The same production equipment used in Niederwinkling is being used at Bydgoszcz following the TE internal transfer process to assure quality outcome. This change was carried out as part of our footprint strategy to expand capacity and make our production even more flexible. The following features were considered: -Internal audit of the new production facility has taken place -Same machines and tools are used -Same processes are applied -Same quality standards applied:Frist Article Approval report approved from both TE Bydgoszcz and TE Intercontec, Niederwinkling Germany Teams -Same sub-suppliers and material as Germany.

#### Reason for Changes:

Part status change. This is necessary to cover increased global market demands, local-for-local production, shorter delivery times, risk-mitigation (internal second source) and prevent line stops at customers.
