Overview

- One of Molex's long standing North American supplier of Trays and Lids used to package our connectors is filing for bankruptcy. The company will permanently stop operations. This came to the attention of Molex with short notice and we are taking immediate actions to work to minimize the impact to our production lines and products we ship out.
- Molex is working to recover our tooling from this vendor. The tooling will be relocated to two existing Molex North American Suppliers.
- Our goal will be to make use of this tooling where possible, to secure raw materials and to reestablish production.
- In some cases, we have up to 8 weeks of packaging inventory. In others, the supply is measured in days.
- If the tooling cannot come back on line, new tooling will have to be produced.

Overview Continued

- This situation will remain fluid for the next several weeks as we work to regain control of our assets and resume tray supply into Molex.
- Our goal will be to recreate the trays and lids that you receive today with the same or equivalent materials. If we are unable to accomplish this, Molex will make contact with your company to work through an agreeable short term and long term solution.
- Molex production plants impacted by this situation are Lincoln NE, Nogales MX and Little Rock AR.
- This notification is to communicate the change of supplier for our trays and lids only. Product packaged within these trays and lids will be unchanged
- Packaging supplier change only, no PPAP or Samples will be provided
