DESCRIPTION

Bostik Breathe is a noise-free, chemical-based humidity absorber that absorbs moisture in the air and prevents condensation issues. Bostik Breathe is fits in all home spaces, suitable for use in; bathroom, kitchen, laundry rooms, bedrooms, living rooms.

Bostik Breathe does not require electricity and absorbs moisture through chemical-based unique tablets, which contain no colourants, perfumes or any other additives. The tablets absorb moisture from the air and converts into a liquid solution which is collected in the tank.

A total refill with two tablets total to 500g, covering rooms up to 25m² and will last up to 4 months depending on humidity levels in the room. The two-tablet system offers up to 33% higher moisture absorption and 11% additional tablet weight than the market average. One tablet can also be used for smaller sized rooms up to 12m².

The unit is both sustainable and efficient; being made from recycled plastic and food industry waste with an easy-pour spout, spillproof seal and a 1.2l tank capacity. Making it safe and easy for emptying, cleaning and transportation.

APPLICATION

- Lift the unit cover and take the two tablets still wrapped in their covering and open them on one side.
- Insert the tablets into their shelves between the provided pitches. Ensure to avoid any skin contact.
- Close the lid, you now have a working humidity absorber.

CLEANING

- Lift the top cannister housing.
- Empty the liquid solution into the sink or toilet.
- The absorber can be fully disassembled to allow for cleaning and easily reassembled.

STORAGE

- Store at a temperature level not exceeding 40°C. Store for up to 24 months from the date of manufacture. The liquid solution can stain and damage certain materials such as fabric, leather and metals. In case of contact, rinse with lukewarm water immediately.

PRECAUTIONS IN USE

To optimise absorption, place in location exposed to air circulation. To avoid the risk of the unit falling and spillage, please place in an area which avoids the danger of being knocked over.

Refills should be replaced once fully dissolved so the absorber continues to operate.
