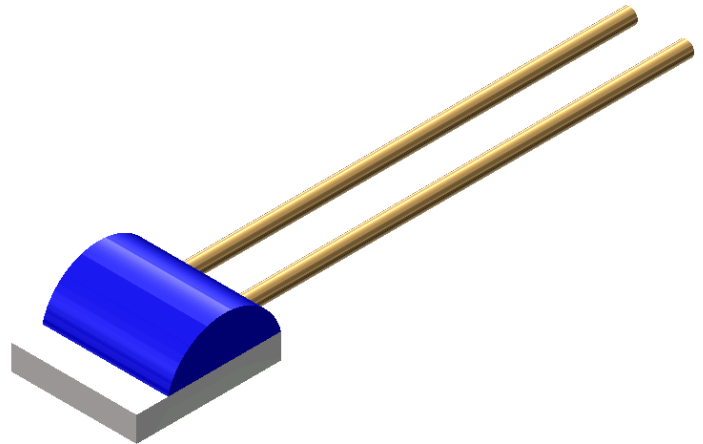
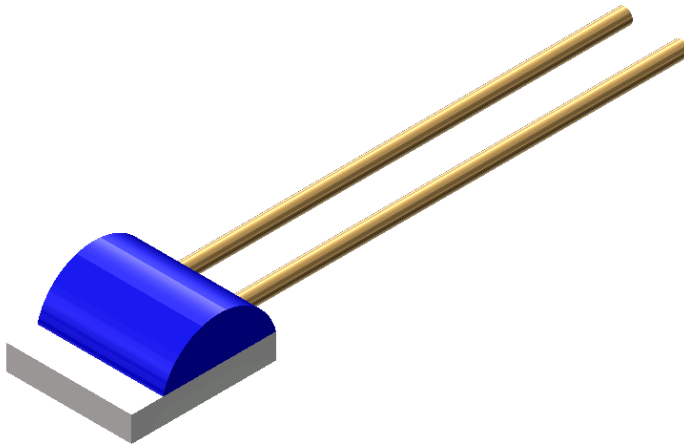

Composition of blue wire fixation material contents some lead. This is currently covered by an exceptional permission.

New fixation material is lead free now and complies to RoHS. No exceptional permission needed.

The current pin fixation material composition contents lead (Pb) which is currently handled by an exception regulation. To keep the parts RoHS compliant in the future the fixation material composition is changed to a lead free composition.
