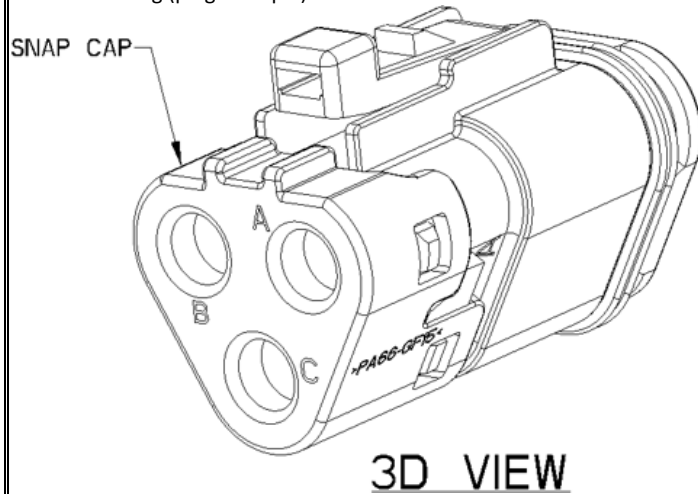

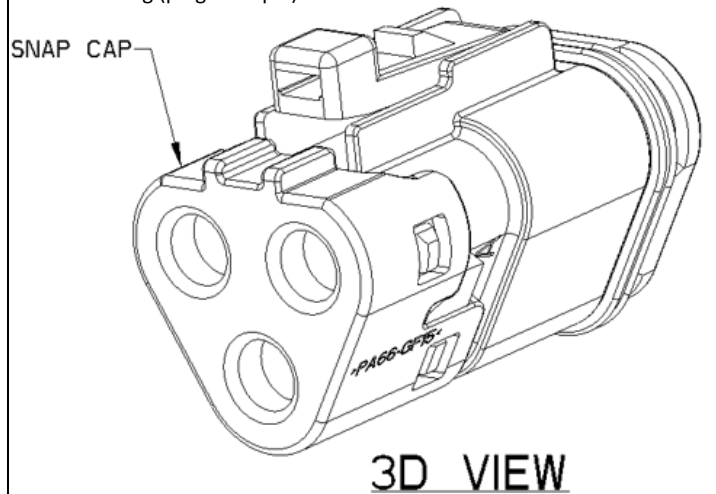
General Description of Changes
