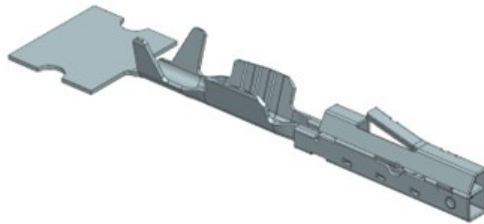

Overview

- This PCN will be applied to Chinese customers only. All below changes will impact Chinese customers only.

1. Existing TAK50 unsealed Sn rcpt terminal are produced in Molex Lincoln Nebraska Plant, in order to mitigate the tariff impact between US-China, and to meet the Chinese customers' expectation on "local supply chain", we plan to duplicate the tooling in China to supply Chinese Customers' demand. The Tooling will be the exact duplication of the current tool.
2. We will qualify additional raw material supplier to ensure material supply continuity. The additional source supplier is already an existing metals supplier qualified by Molex. New material supplier will help Molex keep up with current and future demand in China Market.
3. The above change will follow qualification process of Molex
4. With this change, Molex China plant produced parts will be delivered to Chinese customers. With Molex Lincoln plant produced parts will be delivered to all other regions except for Chinese customers.
