General Description of Changes

Dear Customer This Product Change Notification (PCN) serves to inform you of a manufacturing location transfer. The following part numbers will be transferred from TE's external plant in Japan to TE internal plant in Suzhou, China. At present, these parts undergo stamping and plating exclusively at TE's internal facility in Suzhou, China, while the loose-piece cutting step is handled at TE's external plant in Japan. Moving forward, all manufacturing stages including stamping, plating, and loose-piece cutting will be consolidated at TE's internal plant in Suzhou, China. There will be no expected impact on the form, fit, or function of the affected products at this time. The transfer will be conducted in accordance with a strict internal procedure designed to ensure that product quality, supply capability, and form-fit-function remain unaffected. The new manufacturing site operates under a certified quality management system, compliant with recognized industry standards. An internal qualification and release process, based on our specifications, will be completed prior to the shipment of any products from the new location to ensure performance and compliance. As a result of our continuous strive for improving our processes; thorough analysis of demand picture, matching our customer needs, we are going to optimize value stream of part numbers in scope of this PCN. This transfer will support the need of our customers for shorter lead-times and optimized value streams. A TE-internal release test based on the relevant part specifications will be executed before delivery.
